Subject: - Modified Enlistment Rules regarding Inspection Teams for enlistment cases of ER-2017, ER-2019 & ER-2020.

Following modifications are made in the rule for Inspection Teams in "Rules for Enlistment of Contractors in CPWD"- 2017, 2019 & 2020.

Existing Provision

Enlistment Rules 2020

3.1 Inspection teams

The eligible completed and ongoing works of the applicant shall be inspected by a team consisting of CPWD officers who have jurisdiction over the area where the site of work is located. They shall inspect the works and furnish the report on quality of work and performance of the contractor within 30 days of the request received from the enlistment authority. The composition of inspection team is given below.

- (a) Class I(Super), Class I(AAA), Class I(AA) and Class I(A) (Building & Infrastructure category)
- (i) Chief Engineer of the Zone or SE of the Circle
- (ii) One Executive Engineer as nominated by the CE/SE.
- (b) For Class I, Class II and Class III in all categories
- (i) Chief Engineer of the Zone or SE of the Circle or Director of horticulture.
- (ii) One Executive Engineer/DDH as nominated by the CE/SE/DOH.
- (c) For Class IV and Class V in all categories
- (i) Executive Engineer/DDH of the division
- (ii) One Assistant Engineer/ADH as nominated by the EE/DDH.

Modified Provision

Enlistment Rules 2020

3.1 Inspection teams

The eligible completed and ongoing works of the applicant shall be inspected by a team consisting of CPWD officers who have jurisdiction over the area where the site of work is located. They shall inspect the works and furnish the report on quality of work and performance of the contractor within **21** days of the request received from the enlisting authority. The composition of inspection team is given below.

- (a) Class I(Super), Class I(AAA), Class I(AA), Class I(A) in B&R category and Class I & Class II in all categories
- (i) Chief Engineer of the Zone or SE of the Circle.
- (ii) One Executive Engineer as nominated by the CE/SE.
- (b) For **Class III**, IV and Class V in all categories
- (i) Executive Engineer/DDH of the division
- (ii) One Assistant Engineer/ADH as nominated by the EE/DDH.

Enlistment Rules 2019

5.0 Inspection Teams and Reports

The Inspection teams for inspecting the non-CPWD completed works of the contractor and furnishing their reports on quality of construction, workmanship etc., to the enlistment authorities shall be as below:-

- A. For Class-I(Super), Class I(AAA), Class I(AA), Class I(A) (Composite) and Class I category
- I. Chief Engineer of the Zone/SE of the Circle.
- II. One Superintending Engineer/Executive Engineer as nominated by CE/SE.
- B. For Class II: Category
- I. CE of the Zone/Superintending Engineer/DOH of the Circle
- II. One Executive Engineer/DDH as nominated by CE/SE/DOH.
- C. For Class III, Class IV and Class V and Nursery Category:
- I. Executive Engineer/DDH of the division
- II. One Assistant Engineer/ADH as nominated by EE/DDH.

For inspection of ongoing works, the team will be decided by the enlisting authority.

5.0 Inspection teams

The eligible completed and ongoing works of the applicant shall be inspected by a team consisting of CPWD officers who have jurisdiction over the area where the site of work is located. They shall inspect the works and furnish the report on quality of work and performance of the contractor within 21 days of the request received from the enlisting authority. The composition of inspection team is given below.

- (a) Class I(Super), Class I(AAA), Class I(AA), Class I(A) in **B&R** category **and** Class I & Class II in all categories
- (i) Chief Engineer of the Zone or SE of the Circle.
- (ii) One Executive Engineer as nominated by the CE/SE.

- (b) For Class III, IV and Class V in all categories
- (i) Executive Engineer/DDH of the division
- (ii) One Assistant Engineer/ADH as nominated by the EE/DDH.

7.0 Inspection Teams and Reports

The inspection teams for inspecting the non CPWD works of the contractor and furnishing their reports on quality of construction, workmanship etc., to the enlistment authorities shall be as follows:-

- A. For Class-I(Super), Class I(AAA), Class I(AA), Class I(A) (Composite) and Class I.
- I. Chief Engineer of the zone.
- II. One Superintending Engineer as nominated by CE.
- B. For Class II:
- I. Superintending Engineer/DOH of the circle
- II. One Executive Engineer/DDH as nominated by S.E/DOH.
- C. For Class III & Class IV and Nursery:
- I. Executive Engineer/DDH of the division
- II. One Assistant Engineer/ADH as nominated by EE/DDH.

Enlistment Rules 2017

7.0 Inspection teams

The eligible completed works of the applicant shall be inspected by a team consisting of CPWD officers who have jurisdiction over the area where the site of work is located. They shall inspect the works and furnish the report on quality of work and performance of the contractor within 21 days of the request received from the enlisting authority. The composition of inspection team is given below.

- (a) Class I(Super), Class I(AAA), Class I(AA), Class I(A) in **B&R** category **and** Class I & Class II in all categories
- (i) Chief Engineer of the Zone or SE of the Circle.
- (ii) One Executive Engineer as nominated by the CE/SE.

- (b) For Class III, IV and Class V in all categories
- (i) Executive Engineer/DDH of the division
- (ii) One Assistant Engineer/ADH as nominated by the EE/DDH.

These rules shall be applicable for pending inspections. All the officials are advised to take action in a time bound manner for settlement of old cases.
