Subject:- Modified Enlistment Rules regarding inspection teams for enlistment cases of ER-2017, ER-2019, ER-2020 & ER-2021.

Following modifications are made in the rule for **Inspection Teams** in "Rules for Enlistment of Contractors in CPWD"-2017, 2019, 2020 and 2021.
