## OFFICE MEMORANDUM

CPWD had issued a circular regarding technology neutral EPC tenders vide OM no. DG/MAN/Misc./60 dated 25.03.2022. In this OM, it was mandated that technology neutral EPC tenders preferably be invited in Mode I & II. Mode III is to be used only under specified circumstances after approval of concerned SDG/ADG, as mentioned in the OM.

CPWD is preparing a presentation on new technologies and Implementation of technology neutrality in EPC tenders. <u>Details are required of EPC tenders in the proforma enclosed herewith</u>. However, since the presentation is to be made to highest authority in the Government, it is required that formal report is submitted in the enclosed proforma by each Region/Project Region.
