1. The role and functions of Regional QA units are enumerated in SOP No. 7/2. Guidelines for inspection of works are also detailed in the SOP. As per para 5(iv) of SOP No. 7/2, "SDGs/ADGs shall review QA inspection reports including TPQA reports under their respective Project Regions/ Regions for works costing more than Rs. 20 crores with respect to compliance of observations by field units on quarterly basis and take corrective action as deemed fit."

2. To monitor the compliance of Quality Assurance System by Regional QA units, it has been decided that for every quarter, all SDGs/ADGs shall furnish a report in respect of Quality Assurance Inspections carried out by their Regional QA/ TLQA units along with monitoring of compliance of observations raised, by 10th of the following month in the following format:

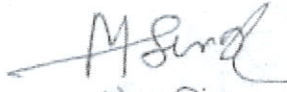
