Subject: Discrepancies in Arbitration cases uploaded in Arbitration Appointment Module and also regarding not uploading all the cases in the Arbitration Appointment Module.

1. During review of Arbitration Appointment Module, it is observed that number of old arbitration cases have been entered by the concerned Executive Engineers in the category "Others" (court appointed arbitrators) instead of selecting the arbitrator from CPWD Empanelled list already uploaded in the Arbitration appointed Module. This has resulted in multiple entries of name of some of the Arbitrators. For uploading old arbitration cases in the module, only names of either Court appointed arbitrators or name of arbitrators not in the empanelled list have to be separately entered by the field officers in the module in the others category (Court Appointed Arbitrators), whereas all other cases are to be entered under CPWD empanelled Arbitrators. A list of empanelled arbitrators already uploaded in the module is attached as Annexure-A for reference of field officers.

2. Further, list of cases in which the name of other arbitrators (Court appointed/Non-Empanelled Arbitrators) had been added separately is enclosed as Annexure 'B'. In the Annexure-B, only following arbitrators are not in empanelled list as either they are court appointed arbitrators or have attained the age of 75 years:

- (i) Shri K.N.Agarwal at Sl. No.2
- (ii) Justice Anil Kumar Sinha(Retd) at Sl No. 3
- (iii) Shri D.S.Zoting, High Court Judge at Sl. No. 5
- (iv) Shri Jagmohan Lal at Sl. No. 7
- (v) Shri Shashank Mehendale at Sl. No. 19
- (vi) Shri K.K.Varma at Sl. No. 23.

All other names in the list at Annexure-B are already empanelled arbitrators and the field officers, who have entered these cases, **are requested to kindly delete the case from the list and enter the case afresh under the category of CPWD Empanelled Arbitrators.** Compliance in this regard may be sent by 9.01.2023 at mail ids cecsq.cpwd@nic.in and delsetlccsq.cpwd@nic.in

3. It is again reiterated that all the arbitration cases may be entered in the Arbitration Appointment Module as limit for handling arbitration cases by the individual arbitrator at a time is fixed as five. Therefore, it is necessary that all the cases are entered in the module so that arbitrator appointing authorities have data available with them at the time of

appointment of arbitrator about number of cases with individual arbitrators so that case is entrusted to only those arbitrators who have less than 5 cases with them.

4. It is also reiterated that only the names of either court Appointed Arbitrators or arbitrators not in the empanelled list are to be entered by the field officers separately under the option of court appointed arbitrators/non-empanelled arbitrators and all other cases are to be entered under category of CPWD empanelled arbitrators only in the module. In case of any issues in uploading cases, ERP Unit /CSQ Unit may be contacted with screen shot at mail id pims.cpwd@gov.in.
