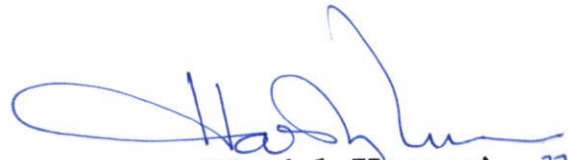

In this regard, your kind attention is invited towards the Point No-3.1.1.1 of CPWD WORKS MANUAL 2019 & SOP No 3/1 of STANDARD OPERATING PROCEDURES FOR CPWD WORKS MANUAL - 2022 vide which CPWD has to issue Memorandum of Understanding (MoU) to the client i.e., NESTS, at the time of submitting Preliminary Estimates for A/A&E/S.

In this context, NESTS has already issued A/A & E/S for both construction & upgradation of EMRSs however, MOU is yet to be initiated by CPWD. A request letter has also been sent to your esteemed office by NESTS dated 14.09.2022 as referred at (1) followed by two reminders as referred above at (2) & (3).

Furthermore, CPWD Bhubaneswar has been writing to NESTS with respect to MoU signing vide its letter dated 12th September, 2022 & 16th November, 2022 hence, kindly suggest a feasible way to undertake this piece of work and issue further necessary directions to all the concerned.

In view of the above, it is requested to initiate the process of MoU as per the requirement of CPWD Work Manual and also kindly ensure that the construction work of EMRSs does not get obstructed due to delay in MoU.

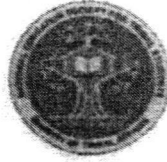

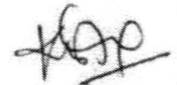

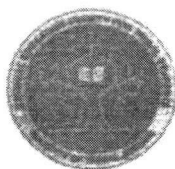
