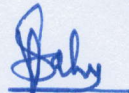
Subject: Guidelines for implementation of e-MB.

In compliance to OM no. 135 of 2023 dated 21.03.2023 of ERP unit, online measurements of work done are to be recorded for payment of works being executed by CPWD. The ERP system of e-measurement shall be adopted in first phase for works at the stations Delhi, Mumbai, Chennai, Kolkata, Chandigarh and Bengaluru. Necessary modifications in Manual / SOP has been done vide OM Nos DG/Manual/2022/07 and DG/SOP/2022/13. However following procedure shall be adopted for use of e-MB in on-going works:

1. For the on-going agreements, the computerised measurement book (c-MB)/computerized level book (c-LB) system is already adopted in the agreements. The ERP system of e-measurement shall also be adopted for on-going agreement with the consent of the contractor. A consent letter shall be taken from the contractor by the Engineer-in-Charge in the format attached with this OM. This consent letter shall become part of the agreement. This exercise should be completed within 15 days of issue of this OM.
2. If any agency does not agree to give consent, letter shall be issued to the agency to give the reason for not giving the consent.
3. If the agency fails to give the consent, even after issue of letter, then system of c-MB / c-LB may be continued.

This issues with the approval of DG CPWD.

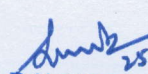

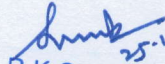
