The following amendment is made in the GCC 2022 EPC Projects and GCC 2020 Construction Works

Clause 10 B ii. Mobilization advance Mobilization advances not exceeding 10% of the tendered value may be given, if requested by the contractor in writing within six months of the order to commence the work. Such advance shall be released in two or more installments to be determined by the Engineer-in-Charge at his sole discretion. The first installment of such advance shall be released by the Engineer-in-charge to the contractor on a request made by the contractor to the Engineer-in-Charge in this behalf. The second and subsequent installments shall be released by the Engineer-in-Charge only after the contractor furnishes a proof of the satisfactory utilization of the earlier installment(s) to the satisfaction of the Engineer-in-Charge. Before any installment of advance is released, the contractor shall execute Bank Guarantee Bonds not more than 6(six) in number from commercial Bank	Clause 10 B (ii) Mobilisation Advance Mobilization advances not exceeding 10% of the tendered value amount may be given, if requested by the contractor in writing within six months of the order to commence the work. The second and subsequent installments shall be released by the Engineer-in-Charge only after the contractor furnishes a proof of the satisfactory utilization of the earlier installment(s) to the satisfaction of the Engineer-in-Charge. Before any installment of advance is released, the contractor shall execute Bank Guarantee Bonds not more than 6 (six) in number from commercial Bank for the amount equal to 110% of the
