Subject: Modifications in Para 3.1.1.5 of CPWD Works Manual 2022 regarding Accord of Administrative Approval and Expenditure Sanction.

CPWD is the premier construction agency of the Government of India and plays a pivotal role in the construction programme of Government projects. It also undertakes the works of attached and subordinate offices under Ministry of Housing and Urban Affairs. The Administrative Ministry/Department/ Client issues A/A & E/S for their works. For works of MoHUA budgetary head, A/A & E/S is accorded by the CPWD officers as per delegated financial powers.

It is adjointed upon that, A/A shall be issued by the attached/subordinate offices under MoHUA & E/S shall be issued by CPWD officers as per availability of funds under budgetary head. Accordingly, following modifications are made in Para 3.1.1.5 of CPWD Works Manual 2022:

3.1.1.5 Accord of Administrative Approval and Expenditure Sanction (A/A & E/S) The competent authority of the Administrative Ministry/ Department/ Client shall accord A/A & E/S on the basis of Preliminary estimate/DPR as the case may be. (Note: For works undertaken under MoHUA budgetary head, A/A & E/S shall be accorded by the competent authority as per powers given in "Compendium of Financial Powers Delegated to CPWD Officers".)	3.1.1.5 Accord of Administrative Approval and Expenditure Sanction (A/A & E/S) The competent authority of the Administrative Ministry/Department/ Client shall accord A/A & E/S on the basis of Preliminary estimate/PPR/DPR as the case may be. For works undertaken under MoHUA budgetary head: 1. GPRA/GPOA Works: A/A & E/S shall be accorded by the competent authority as per powers given in "Compendium of Financial Powers Delegated to CPWD Officers". 2. Attached and Subordinate offices Works: For Works of Directorate of Estates, Directorate of Printing, Land & Development Office, National Buildings Organisation, Town & Country Planning Organisation, Govt. of India Stationery Office and Department of Publication, A/A shall be issued by the respective Department and E/S (as per availability of funds under respective head) shall be issued by the competent authority of CPWD as per powers given in "Compendium of Financial Powers Delegated to CPWD Officers."
