



IB CB: Key Focus Areas and Deliverables

•SHG-VO-CLF bank account

•Opening of SHG-VO-CLF bank account mandatory for profile entry on NRLM MIS

•Formation of VO and CLF (Expected achievement- above 80%)

- •Only **50% SHGs** are federated into VOs UP, GJ, TN, HP, ML, PB, TN to expedite
- •Only **64% VOs** are federated into CLF CH, GJ, MH, TN, HR, HP, AR, ML, MZ, NL, PB, SK, TR, UK to expedite

•Community Funds

- •Release of Community Funds both under NRLM and NRETP (CIF) to be expedited
 - > RF<50% Ach MH, KR, UP, BH, GJ, TN, HR, PB, NE & UTs (except J&K)
 - CIF<50% Ach MH, BH, WB, GJ, AS, KA,MP, TN, UP, HR, HP, PUB, NE & UTs (except J&K)</p>
- **No direct CIF to SHGs.** Only through federations (VO/CLF)
- •SHG member level rate of interest should not be more than 12%




RF Disbursement (% of total SHGs provided RF)







SHG Bank Linkage 2020-21 (% Credit Disbursed against Target)




Average disbursement and NPA

Action for SRLMs

[BH, GJ, HP, MH, MN, OD, PB, RJ, TN, UK, UP, WB]

Sponsoring applications

- Use online loan application system for submission of SHG loan applications to Banks
- Follow-up with banks and expedite disbursement
- Focus on renewal & enhancement of CC accounts.

Reduce NPA

- Ensure repayments in all accounts with overdue or classified as NPA
- Institutionalize a transaction schedule of Min. 12 credit and 2 debits every year in CC loan accounts
- May have a common repayment date for all loans say 28th of every month

Facilitate Prudent Loan Utilization

- Facilitate withdrawal of full sanctioned amount
- At least 1 member from every SHG to be supported to take higher dose of credit for economic enterprises;
- Cap interest rate charged to members @ max 12% pa

Digital Finance

Status

- **©**19438 BC Sakhi deployed across 18 states.
- **©**Over 35000 SHG members identified to be trained as BC
- **©**10485 SHG members (96.6%) successfully passed IIBF certification course
- **©**9774 SHG members on-boarded on DIGIpay through CSC
- ©Disbursed about Rs 4510 Cr since lockdown (Apr 2020)
- ©Cumulatively transacted Rs 10531 Crores in the last 3 years (till Dec 2020)

Action for SRLMs [AS,BH, WB, JH, OD, MP, RJ, UP, CG, GJ, MH, TN, TR, MZ, MG]

- Speed-up identification of potential SHG members to be trained as BC one per GP
- **©**Expedite Training of SHG members through RSETI and on-board them as Digipay Sakhi through CSC
- ©Complete IIBF certification of all existing BC Sakhi
- ©Coordinate with leading banks at state level to deployment trained SHG members as full-fledged BC
- ©Enable dual authentication in all SHGs under model CLF

1.01 Crore SHG members enrolled under health insurance

Large scale enrollment in WB & TN

AP, Telangana, Bihar & Kerala should quickly finalize the schemes/products for life insurance.






Disbursement of Insurance Support Fund to eligible Federations

- 20 scoping studies approved for 9 states
- Cluster initiatives launched under NRETP & Convergence with MSME
- 5 clusters supporting 800 entrepreneurs to be formed in FY 20-21
