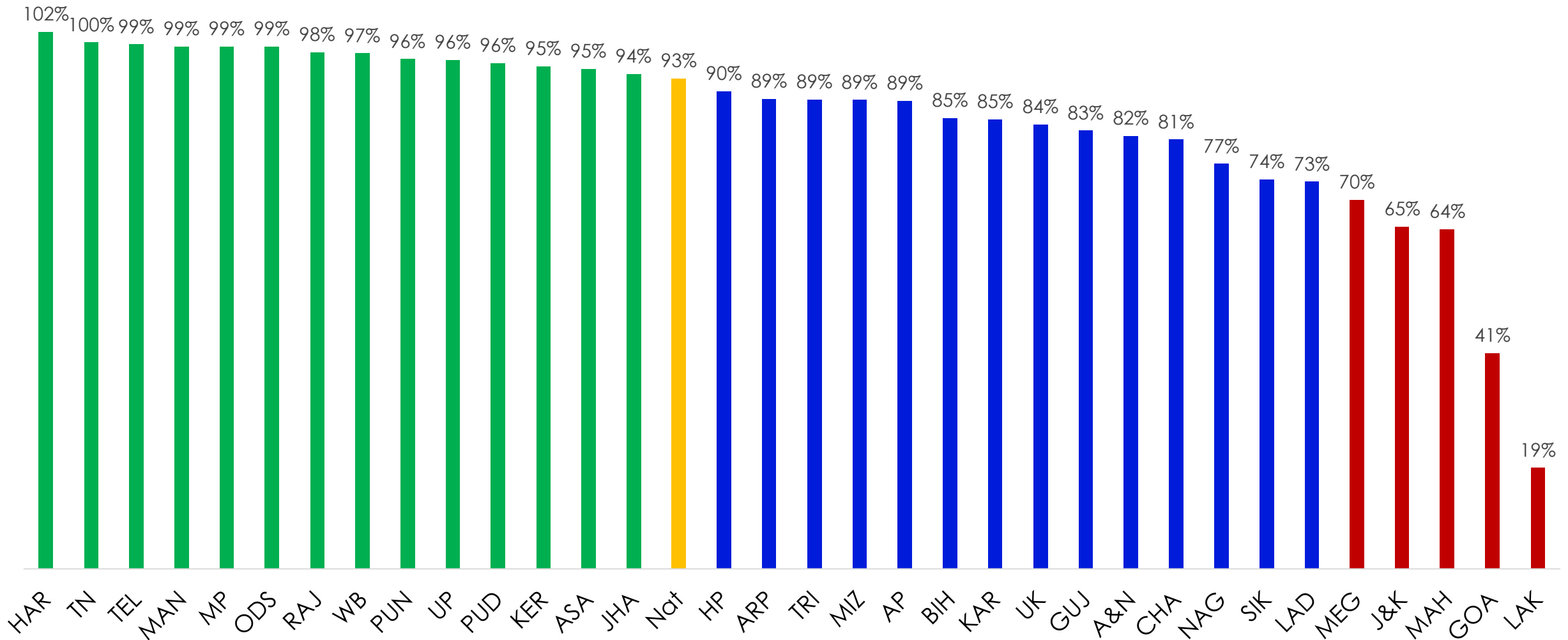

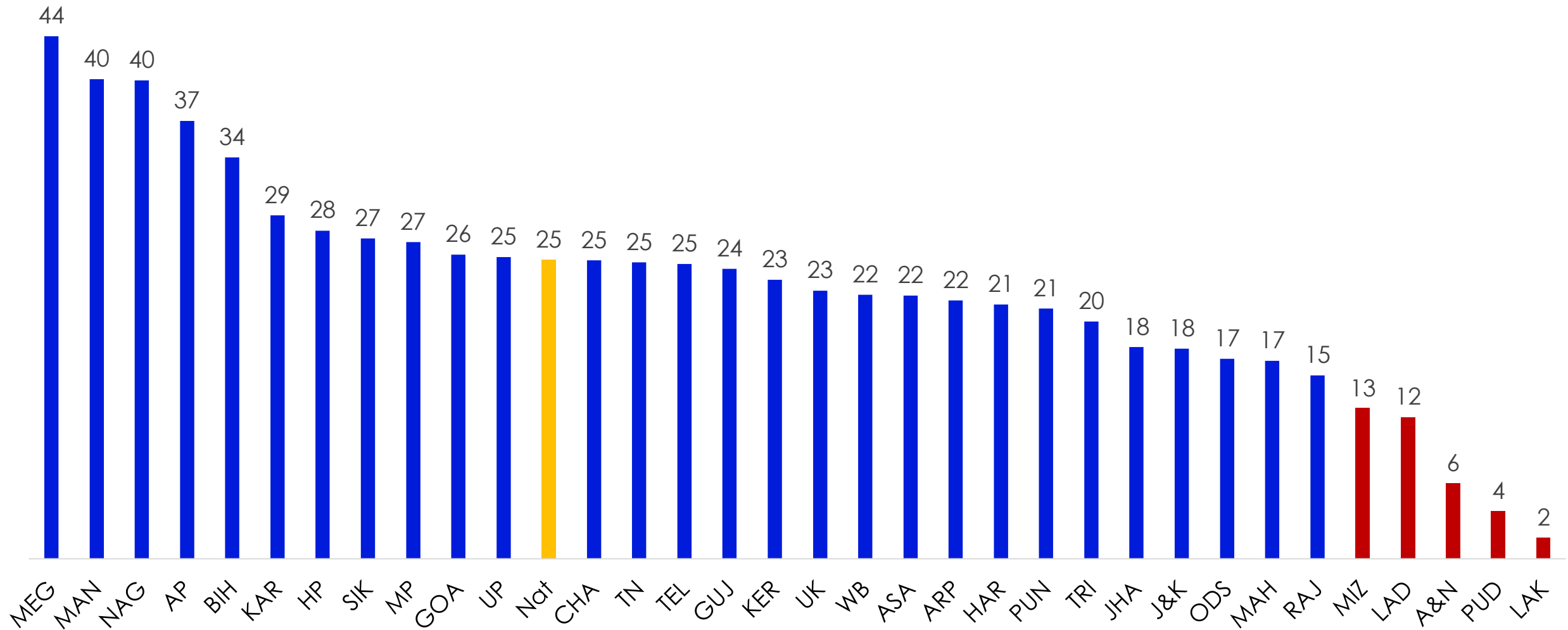
% achievement against annual LB

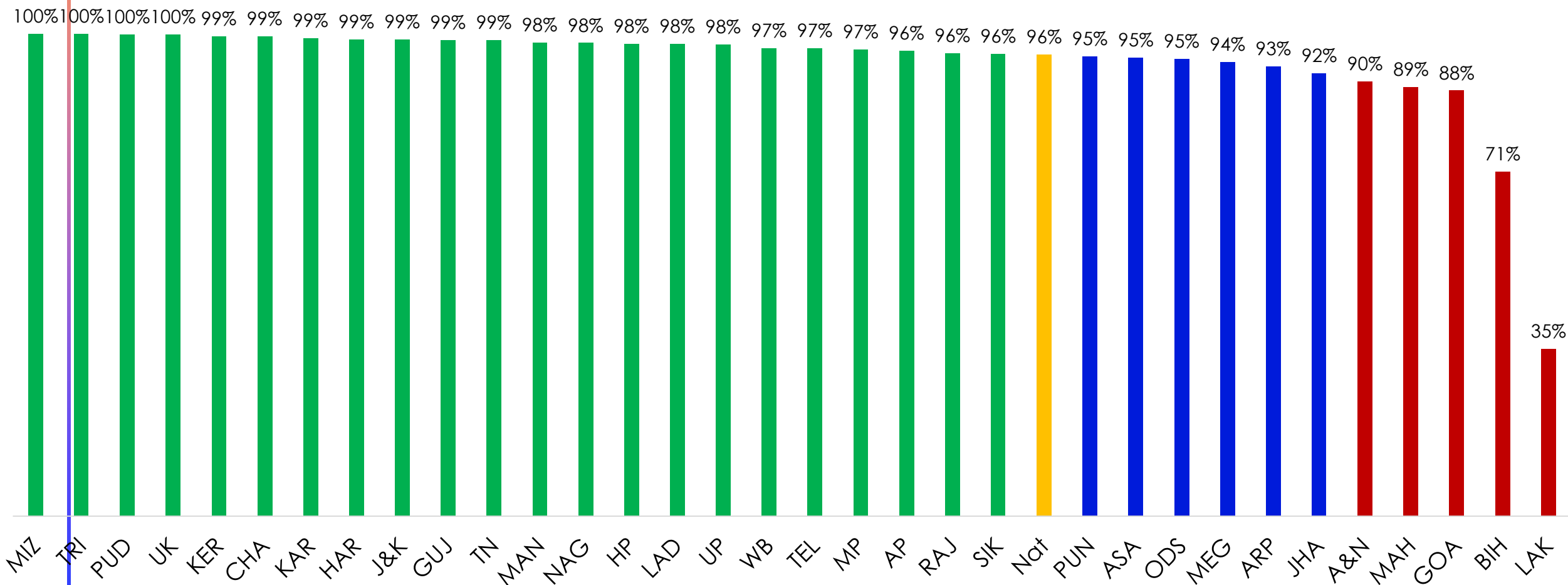
% of Material Component

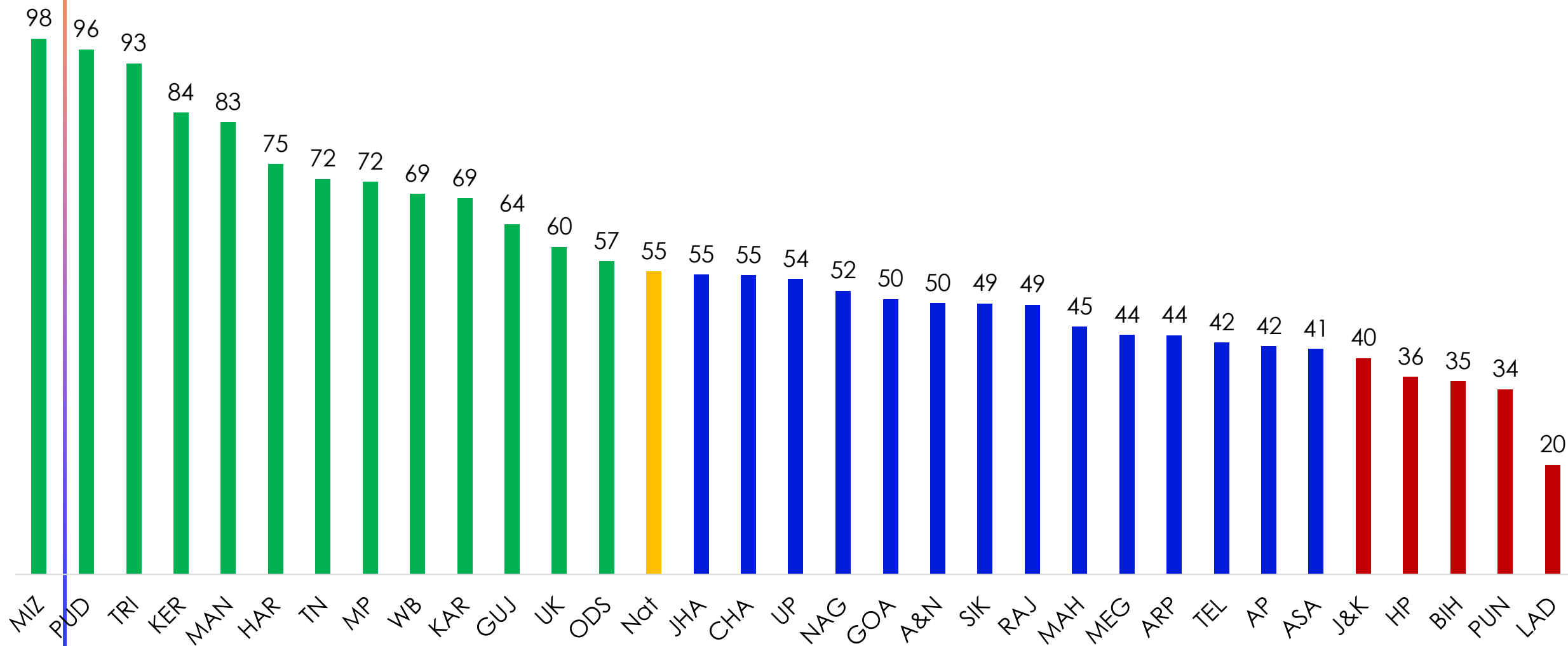

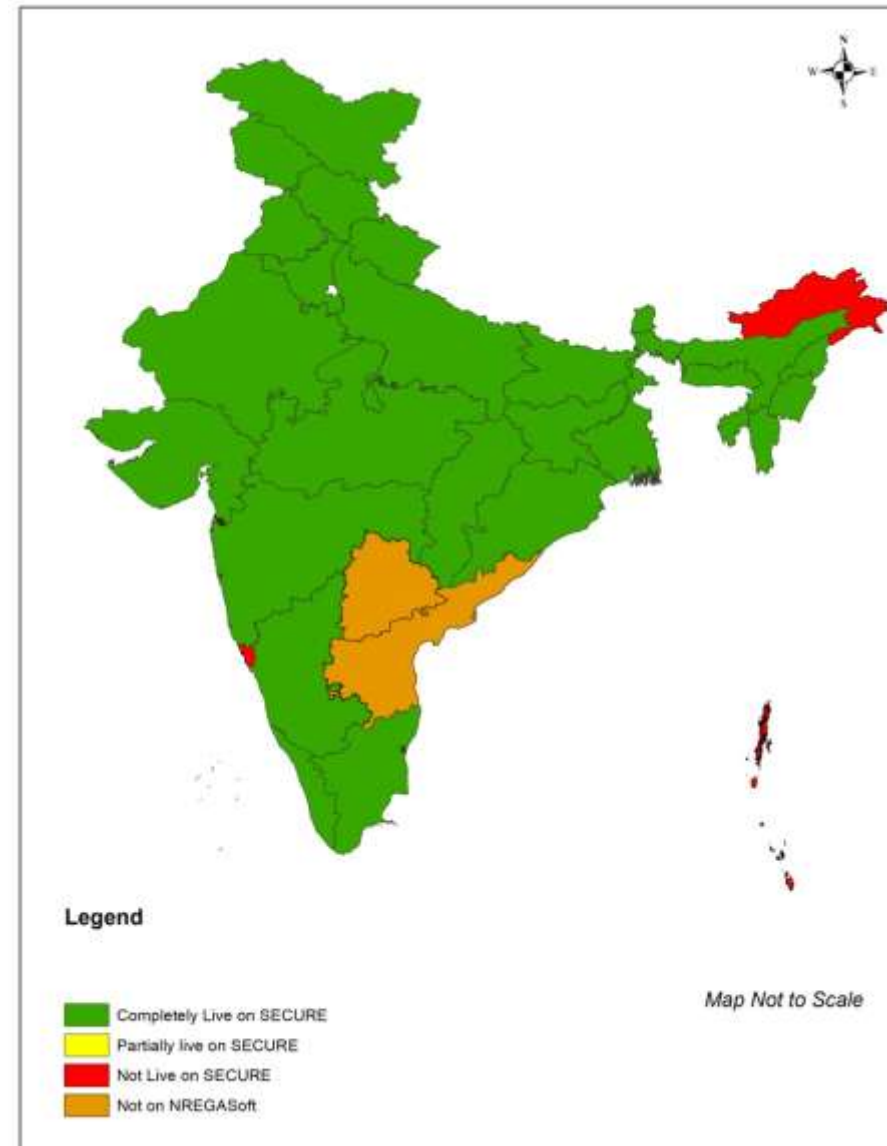

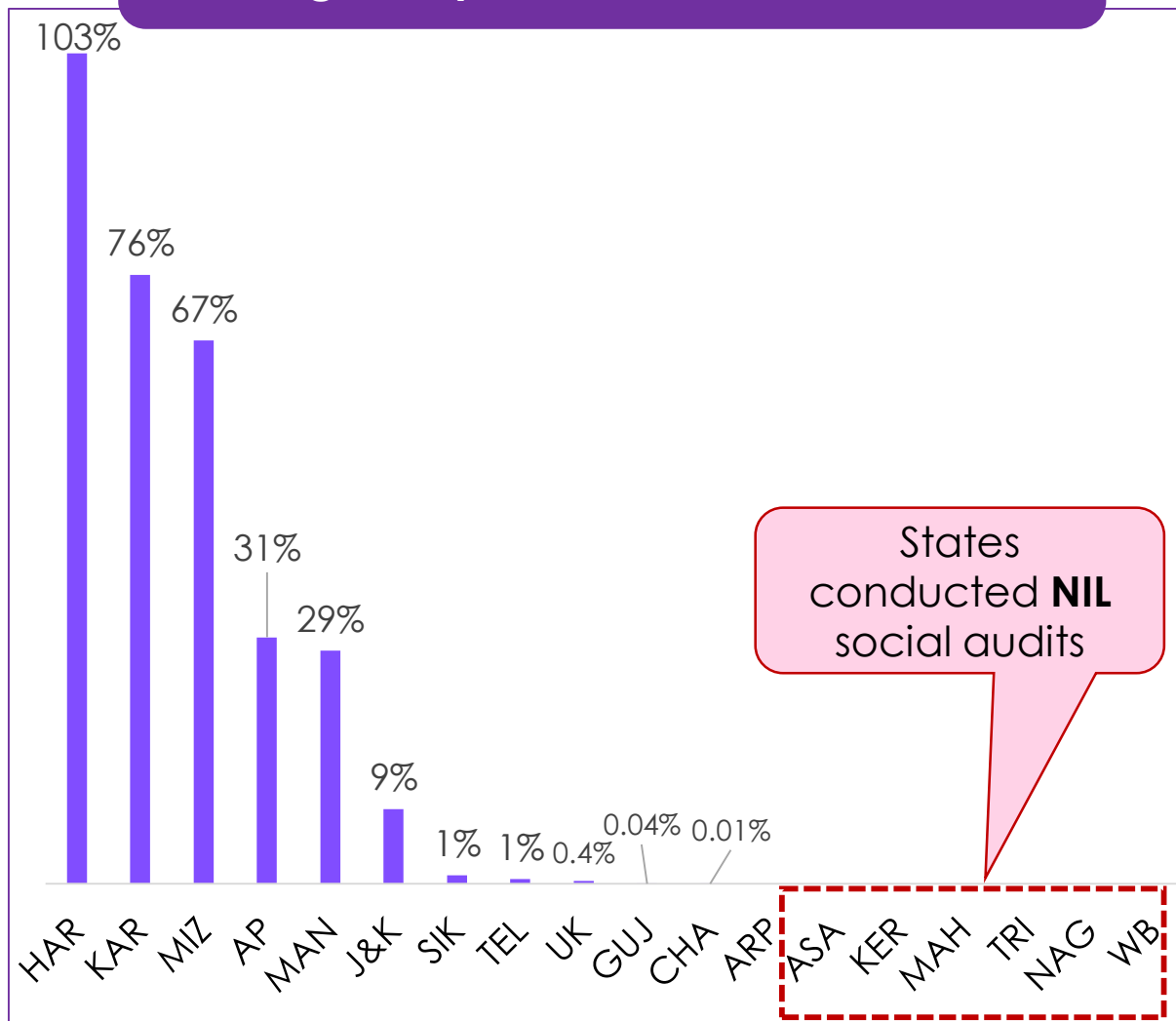

% of Regular Social Audits conducted against planned in FY 2020-21



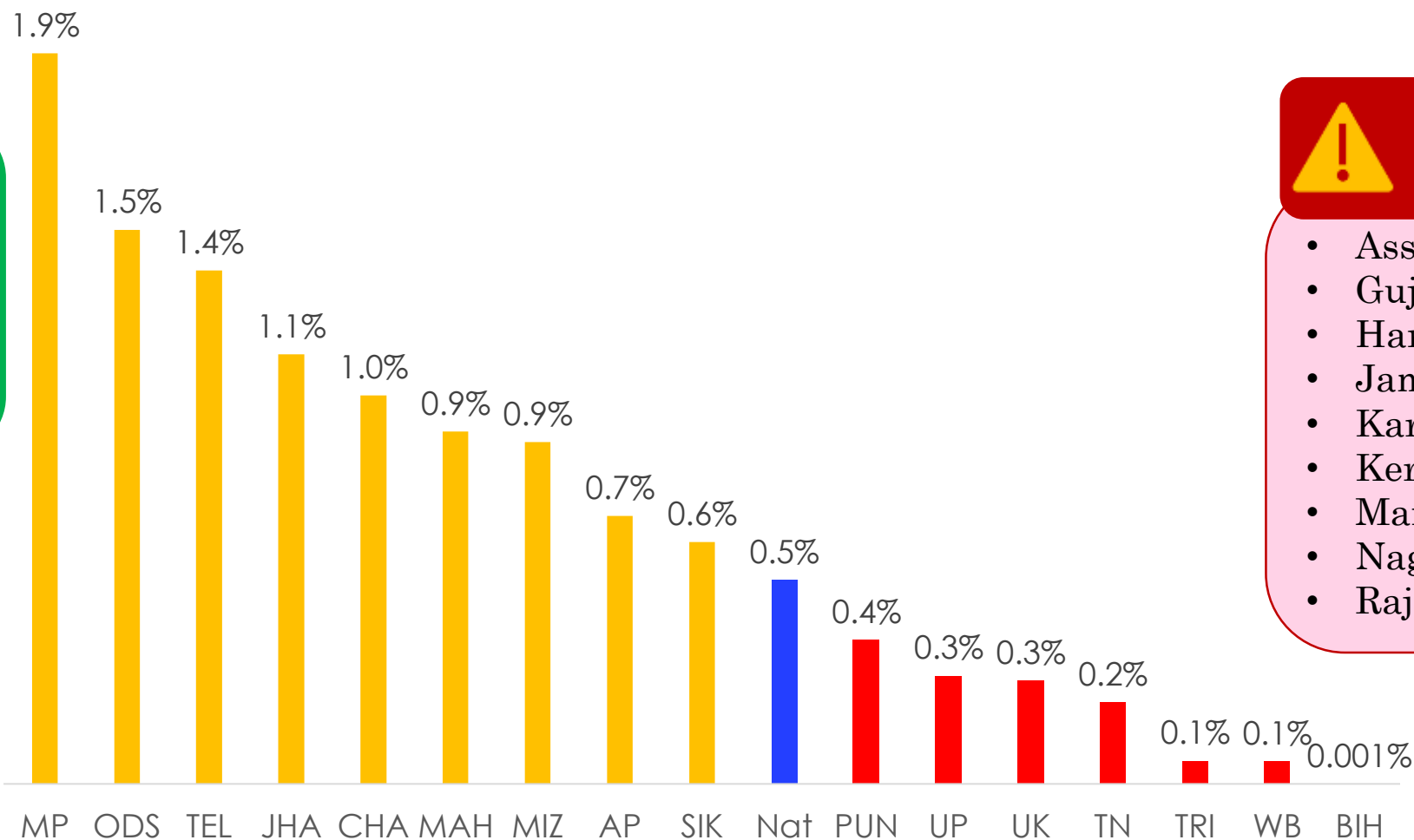

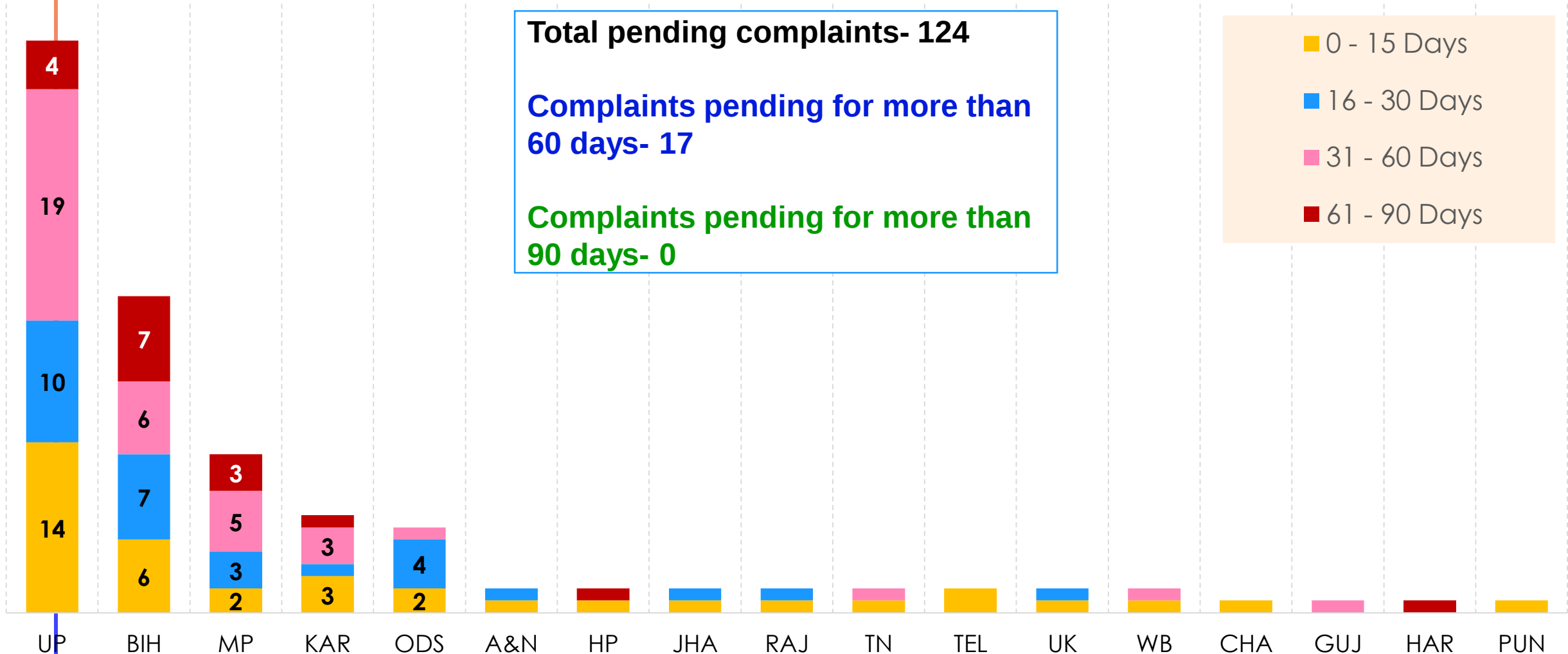

Glimpses from the Field

The project of construction of Basketball ground was taken up in government school premises of Village Kotra Kalan in Block Bhikhi of Mansa District, Punjab. It was long due demand of the villagers to construct a Basketball for children especially for the girls. Gram Panchayat on demand of the villagers took the initiative under Mahatma Gandhi NREGS & Panchayat Fund Convergence. A total of 196 person days have been generated on the project. As a result, Outdoor play enhancing the physical, social, emotional, imaginative and cognitive development of the school children.

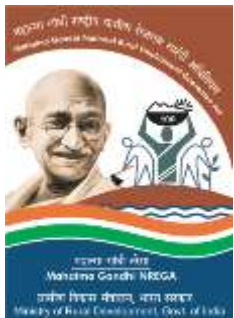

In Devighat GP of Koraput Block & District of Odisha, individual beneficiary Sri Padma Kamara was unable to irrigate his land due to lack of water. Then Farm Pond was taken up in FY 2019-20 under Mahatma Gandhi NREGS. Now through Farm Pond, the beneficiary is able to earn for his family livelihood support through cultivation of vegetable, Maize and Banana on his land.

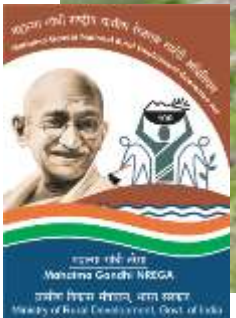

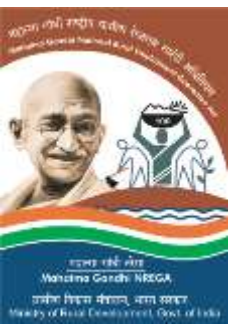
Bamunpathri village of Simlapal Block, Bankura District, West Bengal, is a fully Tribal populated village and the people of this village depend on only daily wage earning but they do not get work regularly in their locality. To stop this seasonal migration of the Tribal people as well as the Socio Economic Development of this village, Raising of Nursery works started under Mahatma Gandhi NREGA in FY 2018-19 with much deliberation. After several meeting with GP functionaries, Pradhan and Bamunpathri Chagal Palan Dal SHG group agreed to take up the work as a challenge. In the last two years good quality plants of Sal, Seagoon, Mango, Papaya, Arjun etc are developed at very low cost. Till now 2 lakhs saplings @ Rs 4.00, total 8 lakh rupees was earned and the workers got wages from the NREGS fund also. Now the workers are self-dependable and have been working all the year on their own land rather than working outside.

Gram Panchayat Baguna is located about 55 km away from Block office Tarikhet, Almora, Uttarakhand. People of this village are mostly dependent on agriculture. To solve the main problem of scarcity of water in the village, works like construction of trenches, khaal, checkdam, renovation of traditional water bodies etc. taken up as top most priority under Mahatma Gandhi NREGA. A resolution was passed at Gram Sabha meeting and all water conservation works were included in FY 2020-21 Plan. 85 Households got employed in which 35 migrant workers also worked. 2569 Person-days generated which is highest in Block Tarikhet till August. Construction of trenches has played a significant role in increasing ground water level and recharging of natural resources. One trench collects almost 900 liters of water. So far 2325 trenches has been constructed which will collect 20,92,500 liters of water.

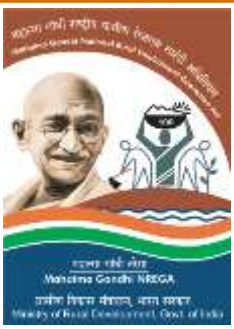
